

COOKIE POLICY

This website LeedsCornExchange.co.uk (“Our Site”) uses Cookies and similar technologies in order to distinguish you from other users. By using Cookies, We are able to provide you with a better experience and to improve Our Site by better understanding how you use it. Please read this Cookie Policy carefully and ensure that you understand it. Your acceptance of Our Cookie Policy is deemed to occur if you continue using Our Site. If you do not agree to Our Cookie Policy, please stop using Our Site immediately.

1. Definitions and Interpretation

1.1 In this Cookie Policy, unless the context otherwise requires, the following expressions have the following meanings:

“**Cookie**” means a small file placed on your computer or device by Our Site when you visit certain parts of Our Site and/or when you use certain features of Our Site;

“**Cookie Law**” means the relevant parts of the Privacy and Electronic Communications (EC Directive) Regulations 2003 and of EU Regulation 2016/679 General Data Protection Regulation (“GDPR”);

“**personal data**” means any and all data that relates to an identifiable person who can be directly or indirectly identified from that data, as defined by EU Regulation 2016/679 General Data Protection Regulation (“GDPR”); and

“**We/Us/Our**” means CX Leeds Limited, a limited company registered in England and Wales under company number 10377866, whose registered address is 5 Hawthorn Park, Coal Road, Leeds LS14 1PQ.

2. Information About Us

2.1 Our Site is owned and operated by Us.

3. How Does Our Site Use Cookies?

3.1 Our Site may place and access certain first party Cookies on your computer or device. First party Cookies are those placed directly by Us and are used only by Us. We use Cookies to facilitate and improve your experience of Our Site and to provide and improve Our products. We have carefully chosen these Cookies and have taken steps to ensure that your privacy and personal data is protected and respected at all times.

3.2 By using Our Site, you may also receive certain third party Cookies on your computer or device. Third party Cookies are those placed by websites, services, and/or parties other than Us. Third party Cookies are used on Our Site for advertising services, analytics, payment processing and content delivery. For more details, please refer to section 4 below.

3.3 All Cookies used by and on Our Site are used in accordance with current Cookie Law. We may use some or all of the following types of Cookie:

3.3.1 Strictly Necessary Cookies: A Cookie falls into this category if it is essential to the operation of Our Site, supporting functions such as logging in, your shopping basket, and payment transactions.

3.3.2 Analytics Cookies: It is important for Us to understand how you use Our Site, for example, how efficiently you are able to navigate around it, and what features you use. Analytics Cookies enable us to gather this information, helping Us to improve Our Site and your experience of it.

3.3.3 Functionality Cookies: Functionality Cookies enable Us to provide additional functions to you on Our Site such as personalisation and remembering your saved preferences. Some functionality Cookies may also be strictly necessary Cookies, but not all necessarily fall into that category.

3.3.4 Targeting Cookies: It is important for Us to know when and how often you visit Our Site, and which parts of it you have used (including which pages you have visited and which links you have visited). As with analytics Cookies, this information helps us to better understand you and, in turn, to make Our Site and advertising more relevant to your interests. Some information gathered by targeting Cookies may also be shared with third parties.

3.3.5 Third Party Cookies: Third party Cookies are not placed by Us; instead, they are placed by third parties that provide services to Us and/or to you. Third party Cookies may be used by advertising services to serve up tailored advertising to you on Our Site, or by third parties providing analytics services to Us (these Cookies will work in the same way as analytics Cookies described above).

3.3.6 Persistent Cookies: Any of the above types of Cookie may be a persistent Cookie. Persistent Cookies are those which remain on your computer or device for a predetermined period and are activated each time you visit Our Site.

3.3.7 Session Cookies: Any of the above types of Cookie may be a session Cookie. Session Cookies are temporary and only remain on your computer or device from the point at which you visit Our Site until you close your browser. Session Cookies are deleted when you close your browser.

3.4 Cookies on Our Site are not permanent and will expire as indicated in the table below.

4. What Cookies Does Our Site Use?

4.1 The following first party Cookies may be placed on your computer or device:

4.1.1 ARRAffinity is a Strictly Necessary cookie that controls your browser session; and

4.1.2 ajs_user_id, ajs_group_id and ajs_anonymous_id are used by us to monitor site usage.

4.2 The following third party Cookies may be placed on your computer or device:

4.2.1 dpr, presence, wd, act, c_user, fr, xs, pl, sb and datr are set by Facebook. We use the Facebook Like button to integrate Our Site with our page on Facebook.com - a common feature of websites these days. In doing so this causes some cookies to be created by Facebook that detect the number of "likes" and whether you are logged into Facebook or not. You should refer to Facebook's cookie policy. Expiry times range from the end of the session to two years.

4.2.2 crumb is set by Squarespace and prevents cross-site request forgery (CSRF). CSRF is an attack vector that tricks a browser into taking unwanted action in an application when someone's logged in. Expires at the end of the session.

4.2.3 RecentRedirect is set by Squarespace and prevents redirect loops if Our Site has custom URL redirects. Redirect loops are bad for SEO. Expires after 30 minutes.

4.2.4 squarespace-popup-overlay is set by Squarespace and prevents the Promotional Pop-Up from displaying on Our Site if a visitor dismisses it.

4.2.5 squarespace-announcement-bar prevents the Announcement Bar from displaying on Our Site if a visitor dismisses it.

4.2.6 void; continuous_play_v3, __gads, _abexps and _uetsid are set by Vimeo and are used to allow video content to be played on Our Site and the number of views tracked.

4.2.7 intercom-id-*, intercom-lou-*, and intercom-session-* are set by Intercom and enable us to offer a live chat feature on Our Site. These cookies attempt to remember a user such that they may continue their conversation between different pages of the site, and resume the conversation on repeat visits to Our Site.

4.2.8 OptanonConsent, current_tenant, auth0 and auth0l are set by Intercom and allow secure user authentication and ensure the security of the users of Our Site and the data it contains.

4.3 Our Site uses analytics services provided by Google and/or Squarespace. Website analytics refers to a set of tools used to collect and analyse anonymous usage information, enabling Us to better understand how Our Site is used. This, in turn, enables Us to improve Our Site and the products offered through it. You do not have to allow Us to use these Cookies, however whilst Our use of them does not pose any risk to your privacy or your safe use of Our Site, it does enable Us to continually improve Our Site, making it a better and more useful experience for you.

4.4 The analytics service(s) used by Our Site use(s) analytics Cookies to gather the required information.

4.5 The analytics service(s) used by Our Site use(s) the following analytics Cookies:

4.5.1 `_ga` is set by Google and used by Google Analytics to distinguish users. It expires after two years.

4.5.2 `_gid` is set by Google and used by Google Analytics to distinguish users. It expires after 24 hours.

4.5.3 `_gat` is set by Google and used by Google Analytics throttle Our Site's request rate. It expires after one minute.

4.5.4 `ss_cid` and `ss_cvr` are set by Squarespace and identify unique visitors and tracks a visitor's sessions on a site. Expires after two years.

4.5.5 `ss_cpvisit` and `ss_cvt` are set by Squarespace and identify unique visitors and tracks a visitor's sessions on a site. Expires after 30 minutes.

5. Consent and Control

5.1 When visiting Our Site you will be shown a pop-up requesting your consent to set Cookies. By giving your consent you are agreeing to Us using Cookies to provide the best possible experience and service to you.

5.2 You can choose to enable or disable Cookies in your internet browser, however certain features of Our Site may not function fully or as intended. Most internet browsers also enable you to choose whether you wish to disable all Cookies or only third party Cookies. By default, most internet browsers accept Cookies but this can be changed. For further details, please consult the help menu in your internet browser or the documentation that came with your device.
